## Activities Terms & Conditions

- The activation will run from the 3<sup>rd</sup> till 12<sup>th</sup> of January 2025.
- Sonic Activities will run daily from 10:00 am to 10:00pm, during the activation period.
- Sonic Activity area can be enjoyed by kids aged 3 years and above.
- Entrance to the activities will be granted for every AED 300 purchase, single or cumulative, made at any store at Mall of the emirates, excluding Carrefour and services.
- Customers can exchange their receipts for Access vouchers.
- Every voucher can admit 2 kids only.
- Customers may enter every day, given they redeem the spend required for each activation.
- All children must be accompanied by a responsible adult at all times. The Operator does not accept responsibility for the supervision of children.
- Parents are not allowed inside the activity area, but they are kindly advised to stay close, monitor their children and pick them up when they finish all activities in about 15-20 minutes.
- No sharp objects may be taken into the area.
- No food, drink or chewing gum should be taken into the activity area.
- Activities items should not be thrown at each other.
- Fighting or bullying will not be tolerated. Guilty parties will be asked to leave.
- Parents/Guardians are responsible for the behavior and wellbeing of the child in their care and must maintain supervision at all times.
- Report all accidents to a member of staff, to ensure that we can provide any necessary assistance and minimize the potential of reoccurrence. These will be logged and are an important part of on-going safety audits.
- All damages to the property either accidental or deliberate must be reported to a member of staff.
